## Topic: "Why ethics matter in child protection litigation"

This CPPAQ Practice Paper will consider the sources of relevant ethical and professional responsibilities for lawyers, child protection workers and other professionals in child protection litigation. It will explore the concepts of procedural fairness and natural justice as they apply to child protection litigation and will review the Model Litigant Principles. It will critically consider the ethical responsibilities of a broad range of practitioners in the health and legal professions and their practical application. The panel will consider ethical dilemmas experienced in practice, from the Court and disciplinary Tribunal's perspective.

card decisions. Judge Kingham also presides in the health practitioners disciplinary jurisdiction and conducts conferences in disciplinary proceedings against members of the legal profession. In this role, Judge Kingham is required to consider the ethical responsibilities of a broad range of practitioners in the health and legal professions.

*Pam Dowse* has been the Specialist Childrens Court Magistrate in Brisbane since June 2007. As a Childrens Court Magistrate, Ms Dowse considers applications for child protection orders on a daily basis and emphasises the responsibility of the Court to recognise the difficulties that children and young people have and the power of the Court to intervene positively to promote strategies that will help break the cycle. Magistrate Dowse believes it takes time, patience and understanding from everyone involved in the process. She also has 15 years experience presiding in Magistrates Courts in Queensland, since her appointment as a Magistrate in 1997. Magistrate Dowse was admitted as a Solicitor of the Supreme Court of Queensland in 1982. Between 1974 and 1996, she worked at the Supreme and District Courts, Crown Law Office, the Magistrates Courts in Mackay and Ipswich, and Legal Aid Queensland's Brisbane office.
